

# Hughenden Parish Council

he Parish Council has been trying to ascertain the parishioners' wishes with regard to Millennium projects to be initiated within their wards.

Several ideas have been progressed so far including the re-instatement of a row of trees down one side of Cryers Hill. These were planted last year and seem to be thriving to date. The Parish Council thank those willing householders that gave their time to keep the tree outside their home watered last year.

We have also applied for a Millennium tree, which is a cutting from a tree at least two thousand years old. This will be placed in the burial ground at Four Ashes Road. Other suggestions have included placing large trees in several places within the Parish.

One item that has been brought up recently is the provision of a Parish Map. There is assistance available for the funding of such a project but it will require a lot of work by volunteers. This brings me to the major point of the letter. If the public wish this project to get off the ground, we will require a team of volunteers, preferably from all wards within the Parish, who will be willing to 'pick this up and run with it'. If any of your readers are interested could they please contact the Clerk to the Council, Mrs. Lynne Turner on HW 716296 after 1st March 1999. If enough people show an interest, this is something that could be very successful.

# LOCAL OSTEOPATH TO HELP KALASHA PEOPLE IN HINDU KUSH REGION OF NORTH WEST PAKISTAN

During the month of June I will be visiting the far North West corner of the Hindu Kush mountain range in Pakistan. This region is 5000 feet above sea level and is the home of the Kalash people.

So, who are the Kalash and what is the reason for my visit? The Kalasha are a tribe who live by subsistence farming and generally apply the old methods using wooden ploughs drawn by bullocks whilst spades and hoes are their only tools. The Kalasha have their own religion based on the strict separation of the pure (ONJESHTA) and the impure (PRAGATA) realms.

The pure realm is associated with mountain tops (home of fairies or supernatural beings), the high pastures, and goats which are considered the sacred herds of the supernatural.

The impure is the nether or underworld associated with the myth that the world stands on the head of a bull. Earthquakes are associated with the roar of an angry bull hence the bull is thought of as impure.

Ancestors spirits are believed to exit into this underworld after death. Women during childbirth and also their menstrual cycle are considered impure and during these times are confined to a special place called the Bashali House. Despite considerable hardship the Kalasha are happy, friendly, and peaceful people who have high moral values within their own strict culture.

The aim of my visit is to support a colleague,

Maureen Lines who works voluntarily in the area as an Emergency Medical Technician and for the past sixteen years has devoted her life to helping these people in the way of first aid treatment, negotiating for medical supplies, providing a jeep for transportation during medical emergencies, establishing better hygiene and various other activities.

I personally intend to use my osteopathic skills and to offer nutritional advice to a race who suffer many nutritional and metabolic disorders like thyroid dysfunction due to lack of iodine, and other disorders such as ringworm and tuberculosis for which medical supplies are scarce. ## DOG OWNERS

If you keep your copies of the Speen and North Dean News may I ask you to refer back to Issue No. 13 (Spring 98) page number 39 where it gives details of The Wycombe District Dogs (Fouling of Land) Order 1998. The footpaths, grassed verges etc., adjacent to a highway except where the speed limit exceeds 40mph. are all covered by this law with a maximum penalty of £1000 if caught.

I know nearly all our village dog owners are very responsible people who walk our roads with little plastic bags at the ready, but we also have a few who are turning our verges into a veritable health hazard. Possibly these people walk their dogs under cover of darkness as I have never actually seen anyone letting their dogs do this, but the proof is there for all to see.

On walking twice round the village from the shop around Studridge Lane and back, looking both sides of the road I counted 127 piles of dog excrement. Around the Village Hall where children are coming and going to pre-school it is particularly bad and in this area I have often seen a small dog running loose with no owner. If your dog made a mess on your living room carpet you would, I hope, clear it up immediately - surely this should apply when you have your dog out in a public place.

We live in a charming village with no pavement or street lights (thank goodness) but walking round at night necessitates taking a torch and keeping your eyes on the road. I certainly don't think it would be worth us entering The Best Kept Village competition again unless something is done about this situation.

### Speen Shop Charities Committee

Peport of the Meeting to elect members to the committee, which will distribute funds from the shop to organisations within the Village of Speen.

There had been three nominations for the committee. Peter Symonds, Peter King, and Tim Crossley.

The meeting unanimously agreed that all three would be an asset to the committee, and should therefore all become members of the committee. The members who were at the meeting were Jane Fleming, Don White, Judy Booth and the new members as above. New members of the committee introduced themselves to the villagers present.

A question was then raised about accommodation for the tenants of the shop. As one of the tenants was present, it was felt to be useful to discuss this briefly. Jane Fleming outlined the offers that had been made by Bucks Housing Ass. to the tenants. These included the offer of several different types of accommodation for rent in the local area: Prestwood, Lane End and Stokenchurch. An offer was made by The Bucks Housing Ass. to purchase a house in Downley for the shop tenants to rent.

All these offers had so far been rejected. Sharon stated that as they ran the shop, they wanted to live as part of the community, and therefore live in Speen or perhaps Naphill. But all the accommodation so far offered was too far away.

Jane responded that there was no accommodation in Speen at a price that the Bucks Housing could justify buying for one housing unit.

It was decided to explore the possibility of using the funds from the shop to support Bucks Housing in purchasing within Speen. This may not be allowable by the Lottery Commission, or accepted by the organisations within the village, who would lose the revenue for about five years.

Since this meeting we are delighted that Sharon and David have accepted an offer of a house in Hughenden Road.

## The Decline of Neighbourhood Watch in Speen

fter a number of years of slow but steady growth and support from the Aylesbury constabulary, both Speen and North Dean came under the control of High Wycombe as part of the new Chiltern Vale police area. We looked forward to closer ties, more local involvement, and a general continuation of the improvements we were getting used to. Initial handover problems were to be expected - they materialised and were overcome - we thought.

The late Dickie Bird became a familiar voice on the 'RingMaster' system and the early newsheets showed promise. The government had said they were committed to supporting the continued growth of Neighbourhood Watch, and improving the links with local police. However, the regular crime reports stopped coming, the brief newsheet became irregular and remained brief. In fact it all started to fall apart.

We are lucky in this locality that the rate of crime is low, we want to keep it that way. Neighbourhood Watch should not swing into action as soon as the members suffer from a few crimes: it should keep ticking over with regular contact. The street co-ordinators should be able to brief their neighbours about what is happening.

I can honestly say that we are now back where we were over 7 years ago. Aylesbury was providing a quarterly magazine to be passed around to each house - we

don't get this any longer. Thame police station provided a brief extract from the crime computer that was an invaluable source of warning about problems in the surrounding area - we have been denied access to this now.

All the above is how a NHW co-ordinator see it, but how about you?

- Do you see the patrol car as frequently?
- Have you suffered from more crimes?
- Do you feel more, or less, reassured about policing in our villages?

When it comes down to it, these are the really important issues, not just the amount of support your co-ordinators feel they are getting.

RingMaster is a message system that automatically telephones NHW reps with any urgent news or warnings. No news is good news - but continued silence is disconcerting.

#### **PIGOTTS WOOD - NORTH DEAN**

Pigotts Wood won a Chiltern Woodland Award in 1998 for the quality of its management. At the ceremony certificates were accepted by John Morris, of Chiltern Woodlands, as the Manager and by Caleb Wheeler-Robinson, aged 6, youngest of the group of owners.

On November 13th a training day in woodland archaeology was held at Pigotts. It was organised by John Morris of the Chiltern Woodland Project, with the additional expertise of Dr. Nichola Bannister, field archaeologist. The twenty-four participants brought a further range of enthusiasm and local knowledge. Initially Dr. Bannister spoke of sources of evidence and showed slides of features that might be found. The whole group then walked the southern part of Pigotts Wood, identifying and discussing banks, pits and other evidence. Numerous sawpits, some quarries, "swallow holes", tracks, a medieval boundary bank and several charcoal hearths were identified. After a sandwich lunch, groups of 4 or 5 mapped features to be found in the northern part of the wood, which has many boundary banks. In a final session this information was collated on a large scale map of the wood and related to some of the documentary evidence (beginning in the 16th Century). A very successful day – and, as not all who wanted to come could be included, one that is likely to be repeated.

A rather different day will be held in Piggotts Wood on 8th April 10.30-3.30) for 8-12 year olds to learn about woodlands from John Morris as part of the Easter Environmental Activities organised by Wycombe District Council. This is particularly fitting as two of the consortium that own the Northern part of the wood are aged 10 and almost 7 (interested families should ring Stephanie Tebbutt on 421886)

Most of those who drive regularly to Wycombe from Speen and North Dean will have noticed the large bracket fungus on the oak south of the Stocking Lane junction. Last Autumn it rapidly ripened to a striking red – but not everyone knows that this was due to a spray of paint from, it is suggested, a humorous highways worker marking areas for repair ....

# IT COULD BE YOUR SOCIETY/CLUB.... THE ROLE OF THE SPEEN SHOP CHARITY

he Speen Shop Charity is now fully up and running, following an Election Meeting on 8<sup>th</sup> February. What this means for Speen is that the Bucks Housing Association donates the rental income from the Shop (just over £2,700 each year) for us to invest in worthwhile causes. This grant originates from the Bucks Housing Association project to build affordable housing and a shop in Speen, and was one of the terms agreed in return for the significant National Lottery grant that kick started the whole project.

The Charity Committee has guidelines for investment decisions laid down partly by the Lottery and partly by the Committee members. These guidelines or 'Terms of Reference' are as follows:

- The Speen Shop Charity will provide financial assistance for any useful non-commercial purpose, which either satisfies an individual need or is to the benefit of the community.
- The scope of the Charity is restricted to the Parish of Speen.
- There must be a clear and demonstrable educational, medical, social or community need.

- As a general rule funding should not be available from an alternative source.
- The provision of a grant should directly benefit a local individual or group or the village in general.
- The first two grants have now been made and details are posted in Speen Shop.

Application forms for grants are available from the Shop, and the Committee meets quarterly to review applications. The next deadline for applications is 30<sup>th</sup> April and details of grants will be published in the Shop in early May.

#### Finished at Last! - These things take time...

ow that the pavement between Speen School and the shop has finally been completed, it might be opportune to put on record the difficulties the Parish Council have met with, in their efforts to tidy up this part of the village. When the School was built in 1966, a pavement was laid along to the end of Water Lane.

Two years later, the pair of bungalows were built opposite what is now St. Peters Close and the pavement was extended along to the drive of the furthest bungalow. In 1976, the Parish Council considered various improvements regarding provision for pedestrians in the village, and the Chairman and Clerk met with the then Divisional Surveyor, Mr Rivett, with a view to continuing the pavement all the way down to Speen Chapel.

At that time, three houses had been built alongside Rosebank Cottage and it seemed logical to provide pedestrian access to the Shop and School. The County Council were not in favour as too many pavements detract from the rural aspect of villages.

Meanwhile the population of the village was rising and in 1986 the Parish Council put in a request to the County Council to complete the pavement along to the Shop. At that time, financial restrictions prevented capital works of this nature, which were not considered of vital importance. Three years later, the Shop closed and the Parish Council were informed that the pavement would not be extended until some form of redevelopment of the site was completed. The Parish Council considered that to be a danger spot and several further official requests were made but the County Council would not undertake any work. They intended to make completion of the pavement a condition of planning consent for the Shop redevelopment, thereby saving the Local Authority the expense of undertaking the work.

When the Shop site was finally developed, the Parish Council again urged the County to complete the path and were informed that a small amount of land in front of Monimail and Hamilton Cottage would have to be acquired to provide sufficient width. The County Council put the onus of these negotiations on the developers of the site, after protracted negotiations, which, as will be seen, were conducted separately with each frontage. The whole matter was finally concluded at the end of 1998.

In order to complete the pavement as soon as possible, the Parish Council undertook to pay for the work at the front of Hamilton Cottage, again owing to the financial problems of the County Council.
